LESSON OBSERVATION, SELF REFLECTION, ONGOING PROFESSIONAL DEVELOPMENT

Important Information

Part of our requirements as an SRE Approved Provider, is to demonstrate that our SRE teachers are not only receiving initial training, but also demonstrate evidence of ongoing training and professional development every 12 months.

Below is a brief outline of the yearly requirements and where there are exemptions and exceptions. If at any stage during the year you feel you may not be able to fulfil these requirements or your circumstances change, please contact us as soon as possible to discuss your situation and arrange an alternative that works for both parties.

Observation Lesson

A new teacher must undertake to have a lesson observed within their first term of teaching and then every 12 months after that.

Observers can be Pastor or other paid ministry staff, SRE Coordinator, a teacher* or retired teacher, another SRE teacher. We ask that family members do not observe each other as it can be biased in offering an honest appraisal.

*DoE staff member from your school can observe but only with principal approval.

Observations can be submitted to our office during Term 3 or 4. **They must be received by the first week** in **December.**

Please use our documentation where possible. If your coordinator is from another denomination, please offer this paperwork for them to complete, if they will be the one observing you.

If you are an employed High School SRE teacher, and you are required to complete Lesson Observations as part of your terms of employment, you can send us a copy of your observations completed in this capacity.

Exemptions- Trained teachers, Paid Pastors, SRE helpers, SRE teachers only filling in, in a casual capacity. To seek exemption, you must contact our office to discuss. We require evidence of your status to offer exemption)

Self-Reflection

All regular SRE teachers, regardless of exemption offered for observations, must complete an annual Self-Reflection. **No RPL is offered for this.**

Exemptions- Helpers & Teachers with casual/fill in status. (Contact us if you need to check what we have on file for you)

Ongoing Professional Development

SRE teachers are to complete two hours of additional training. Suggestions include but not limited to:

- Completing training offered by curriculum writers.
- Attending SRE conferences or child related conferences that can assist with SRE teaching.
- Complete Refresher Training in the Modules mentioned above (in the year of reauthorisation)
- Complete external courses that can enhance your teaching experience.
- Locally run workshops on teaching tips or ways to enhance your lessons.
- Employed HS teachers attending webinars/training/conferences provided by their board or employer.
- Accessing school in-services run through staff or P& C.
- Support training offered to Coordinators either through your Approved Provider or ICCOREIS.

Exemptions- Helpers & Teachers with casual/fill in status.
